APPLICATION FORM (ATHLETE / TEAM) HABAWABA BRASIL 2023

REQUESTS

to Associação Bauruense de Desportos Aquáticos, authorized by Waterpolo Development Association (WPD), the registration of athletes and crew from the Club/Association mentioned in this document which were listed in the registration on application for HaBaWaBa Brasil 2023.

DECLARES

- There is express authorization, issued by the national entity for the protection of the rights of children and teenagers, under their full responsibility, for their athletes to take part in the HaBaWaBa Brasil Festival 2023;
- The minor athlete is in perfect physical and mental health, as well as that the parents of these athletes are required to notify, immediately, "ABDA" if on the date of the Brasil Festival of 2023 the health condition of the children is not ideal for the purpose of taking part in the event;
- That they are aware, due to the duty to care for the minor athletes, who themselves will be under constant supervision of their guardians, tutors, technical committee, following, in full, the General Regulations of the Festival, exempting, in full, "ABDA" of any and all liability arising from personal injuries and/or damage to properties that may occur during the event.
- That they exempt "ABDA" from any and all liability arising from the conduct of underage athletes in relation to damage to persons, third parties, properties, and the accompanying persons designated by the Club / Association are solely responsible for the supervision of the athletes.
- That they will indemnify "ABDA " from any and all damages arising from the conduct of the underage athlete;
- That all the athletes of the participating team are formally connected to the Club/Association and that this maintains in force a compulsory sports insurance policy for each athlete;
- They give consent to the exclusive use and exploitation of the images and videos made by "ABDA", directly or indirectly during the event and/or during the initiatives promoted by "ABDA" and / or sponsored by the Brazilian Confederation of Aquatic Sports ("CBDA") and other affiliated Aquatic federations at all levels, which represent - alone or together with third parties - the athletes / participants of the team in the event, in accord with the terms within "Release", regarding the use of audio, video and photographic materials. It is strictly forbidden to use images, videos or audio in contexts that affect the personal dignity and decorum of each participant and/or "ABDA". The configuration and use of the images are understood as absolutely free and it is agreed that the exclusive right to exploit these images and videos in any form and modalities belongs to " ABDA";

- Accepts that "ABDA" may disqualify a single athlete or the entire team from the Festival if some or all of the hypotheses mentioned in the previous topics, necessary for the acceptance of the "Registration Requirements", are not fulfilled;
- In relation to any dispute related and/or arising out of and/or related to the conduct of the HaBaWaBa Brasil Festival 2023 or the interpretation, validity and effect of this document, arising between "ABDA" and / or the participants of the event (athletes, companions, family members, employees, etc.) and / or persons exercising parental rights/child protection, but not limited to compensation for damages to persons and/or property, suffered during the tournament, damages to participants and/or third parties arising from the conduct of participants and / or third parties will be applied, exclusively, the Brazilian national legislation.

The Club / Association also **DESIGNATES AND APPOINTS** as escorts and guardians for the travel and responsible for the care of the underage athletes mentioned in the registration during the HaBaWaBa Brasil Festival 2023 the adults from the technical committee also registered on this very on line registration.

The escorts / Guardians mentioned above:

- They assume the obligation to perform all tasks entrusted to them, such as, but not limited to, accompanying and/or transporting young athletes, completing all administrative documentation that may be required before and after the competition;
- They assume the obligation, during the duration of the event, to prevent the participating athletes, under their responsibility, from moving away from the site of the HaBaWaBa Brasil Festival 2023;

TERMS OF CONSENTE FOR DATA USE

The Club / Association and the authority for the protection of the rights of children and adolescents / parental protection, having read the conditions for the use of personal data, accept them, in their entirety, provided that they are used in the context of the Organization of the Festival and prove necessary to facilitate the relationship with the "ABDA".

INFORMATION FOR THE USE OF PERSONAL DATA

1. SOURCE OF PERSONAL DATA. In accordance with current Brazilian national legislation, we inform that the personal data kept by "ABDA", obtained from the registration of athletes and their teams, will be treated with confidentiality, and can not be the object of use or disclosure, except for the execution of the festival and if required by national authorities.

2. OWNER AND RESPONSIBLE FOR THE USE OF DATA. The Data Controller, or the person responsible for making decisions regarding the purposes, methods and security of personal data, is the Associação Bauruense de Desportos Aquáticos, located at Fábio Geraldo Street, Nº 2-12, Jardim Solange, in Bauru-SP, CEP 17054- 686.

3. PURPOSE OF THE USE OF THE DATA PROVIDED. Personal data will be processed by "ABDA" for purposes related to:

- a) the organizing and performing of sports activities in accordance do the Law nº 9.615/98;
- b) the fulfilling of legal obligations, sports regulations, community legislations, as well as the instructions issued by the legal authorities;
- c) the processing aims for the publishing of pictures and images to reveal the identities of the interested party on the association websites www.habawaba.com and www.wpdworld.com or in releases of any kind made by “ABDA” solely for the promotion of Habawaba Brasil Festival 2023;
- d) organization of events involving “ABDA” for sponsorship purposes.

4. METHODS OF DATA USE. Regarding the purposes stated, the processing of use of personal data is carried out through manual, computerized and telematics tools and, in any case, in order to ensure their the security and confidentiality.

5. CATEGORIES OF PROCESSED DATA. The processed data are only common personal data and are not sensitive and / or judicial data.

6. ADDRESSES AND CATEGORIES OF SUBJECTS TO WHICH DATA MAY BE TRANSMITTED. Personal data collected will be processed exclusively by authorized personnel and / or the designated Data Processor. In addition to the matters legitimized by law, the collected data can then be reported to the Brazilian Confederation of Sports in the Water (“CBDA”), Water Sports National Federations, Citizenship, Ministry of Sport, the Brazilian Olympic Committee, entities, businesses, or those who maintain a relationship with “ABDA”, to the activities of the organization, management, advertising, sponsorship of events, competitions and sports events; the entities or companies which carry out activities, such as insurance companies, affiliated with “ABDA”, or the activities of health care in favor of “ABDA” of or relating to the insurance companies referred to above, individuals who carry out activities on the processing of data on behalf of “ABDA”.

7. EXEMPTION FROM CONSENT. The provision of personal data is mandatory for the processing purposes described in this statement. Any refusal to provide data may result in non-participation in sports activities promoted by “ABDA”.

8. TRANSFER ABROAD. Personal data collected should not be transferred outside the territorial context of Brazil.

9. STORAGE PERIOD. Personal data collected will be kept for a sufficient time to fulfill the purposes of the Festival and the legal obligations that arise from it.

10. RIGHTS OF THE INTERESTED PARTY. The Regulation recognizes the rights of the interested parties below which can be exerted against “ABDA”;

- a) access to data from the interested party for confirmation that the data are being processed or not;
- b) Right to rectify: the interested party can request the correction of all imprecise personal data related to them, without any undue delay. Bearing in ming the purposes of the treatment, the data owner has the right to obtain the integration of incomplete personal data, also providing an additional statement;
- c) Right of cancellation: to the data owner is ensured the cancellation of their personal data, without undue delay, as long as they are supported by the current Brazilian national law;
- d) Right of limitation: to the interested is ensured the limitation of data processing from their personal data when authorized by Brazilian national law;

e) Right of opposition: to the interested is ensured to oppose at any moment, for any reasons related to their specific situation, to the treatment of personal data related to them, including profiles based on these dispositions.

USE OF AUDIO, VIDEO AND PHOTOGRAPHIC MATERIALS **DECLARES THE FOLLOWING**

That there is no obstacle to grant the following authorization and full responsibility is taken for the lack of veracity of the statement.

Authorization is granted to "ABDA", or any third party for them appointed, to photograph, film or record athletes and all of the staff, by any means available, as well as the statements made, to the services, including but not limited to, the broadcast of the Festival for promotional purposes, internal advertising (Festival), thus transferring to "ABDA" all-rights-of-use and commercial exploitation, in any way or manner, in whole or in part, without the limitation of time, language and space, with the right to pass freely to any third party without need for any future consent.

For the purpose of this authorization, "ABDA" will have exclusive rights to: record, repair, reproduce by any means, communicate, transmit, disseminate the audio/visual/photographic material of athletes and technical teams by any means and/or transmission and broadcasting system, current or to be developed in the future.

For these purposes, "ABDA" will be the sole and permanent owner of all rights of use and economic exploration of the result material, in its totality and of its every piece (to be more specific all result material, including the preparation and tests, pictures of the minor) without any limits, in any location and by any means currently known / to be invented in the future; to produce and publish the result material in the context of commercial initiatives (promotion, merchandising, etc.) related to the festival; to broadcast and use clips, extracts, sequences and/or images containing the performance and/or recovery of the minor, also to complete complex works or others, such as but not limited to, specials, backstage, promos, kinds of publicity.

It is confirmed that "ABDA" is expressly exempt from any obligation and/or its relative cause of effective recovery and/or use of the materials produced; the failure or incomplete use of which cannot give rise to any right or claim in favor of the undersigned, the minor or third parties.

It also authorizes "ABDA" to recover and record the image of the athletes for the purposes of the Festival.

They declare that they have nothing to claim from "ABDA" and / or its appointed parties and in general from anyone who uses or exploits, as presented in the topics above, the benefits and/or the lesser anywhere, even for purposes other than those for which it was made, in order to ensure its correct exploitation.

Guarantee to have legal representation of underage athletes, being responsible for the veracity of the statements made.

They are aware that the materials produced will be used exclusively for the purposes mentioned above and that the "ABDA" guarantees that the use of said material will be carried out in such a way as not to threaten the dignity of the athletes and technical team.

They declare that they have nothing to claim from "ABDA" and its appointed parties, whether in the present or future, regarding the disclosure of the materials produced.
